Date: 26 July 2023

During period from 30 November 2014 to 4 August 2022 (the "Affected Period"), the dividend composition information of the unit classes (each, a "Relevant Unit Class", collectively, the "Relevant Unit Classes" as specified below) of several sub-funds (collectively, the "Relevant Sub-Funds" as specified below) of the Trust published on the Manager's website hk.allianzgi.com (the "Website") pursuant to the SFC's requirements was incorrect, where the proportion between the net income and capital of dividends distributed for the Relevant Unit Classes was wrong (the "Error"). Please note that the Website has not been reviewed by the SFC.

The Manager has taken immediate action by appointing an external auditor to conduct an independent review of the dividend composition information to ensure its completeness and accuracy. Based on the review by the external auditor, the Manager confirms that the dividend composition information in respect of all other unit classes of the Trust, other than the Relevant Unit Classes of the Relevant Sub-Funds, has been correctly disclosed on the Website throughout the Affected Period. The current dividend composition information is available from the Manager upon request and also on the website (hk.allianzgi.com). The contents of this website have not been reviewed by the SFC.

The Error only affected the disclosures published on the Website only. It did not affect the calculation, amount or payment of the dividends themselves, nor the net asset value per unit of the Relevant Unit Classes during the Affected Period. Moreover, the Error did not impact the operations of the Relevant Sub-Funds as redemption and subscription of units were transacted at correct unit prices and net asset values of the Relevant Unit Classes during the Affected Period. In light of this, the impact of the Error on investors is expected to be minimal. Please contact the Manager if you wish to know further details about the Error (e.g. the magnitude of the Error, the relevant Affected Period for a particular Relevant Unit Class, etc.).

After a thorough review and investigation of the incident, it was discovered that the Error resulted from incorrect data input from the fund administrator of the Trust and another service provider appointed by the Manager, IDS GmbH, due to the adopting of a wrong calculation model, inadvertent human oversight and miscommunication between these operators.

We have worked with our service providers to enhance internal controls to avoid recurrence of similar incidents in the future.
